

Description: Rivian has determined that on certain R1S and R1T vehicles, the front passenger seat belt system does not comply with FMVSS 208 S14 which requires certification to frontal barrier belted and unbelted crash test performance requirements. This condition may result in a noncompliance with FMVSS 208, Occupant crash protection.

If a passenger is seated in the front passenger seat and the seat belt automatic locking retractor is reporting on incorrectly, the passenger air bag may not deploy as intended. In the event of a crash which is supposed to deploy the front passenger air bag, the occupant may have an increased risk of injury due to a reduced deployment or lack of deployment.

Description: Rivian has decided that certain model year 2022 2023 Rivian R1S vehicles fail to conform with Federal Motor Vehicle Safety Standard No. 108 Lamps, Reflective Devices, and Associated Equipment."

When the vehicle is in reverse, the back-up lamps will illuminate. However, the optical center may not be visible from the specified planes. This noncompliance may affect visibility and potentially increase the risk of a crash.

Remedy: Rivian will replace the backup lamps that do not meet regulatory visibility requirements.
