**Description:** Rivian Automotive, LLC has decided that certain model year 2023-2024 Rivian R1S, R1T, and EDV vehicles fail to conform to Federal Motor Vehicle Safety Standard FMVSS 108 (Lamp, reflective devices and associated equipment - 571.108 S10.14.6)

The headlamps are aimed slightly too low and do not meet current production specifications or fulfill the requirements of FMVSS 108 (Lamp, reflective devices and associated equipment - 571,108 S10,14.6). Headlamps that are not aimed properly can result in insufficient illumination of the road while driving, which may increase the risk of a crash while driving at night.

**Remedy:** Rivian will check the headlamp adjustment on the affected vehicles and correct it, if necessary.
