Diminished lighting performance may cause reduced visibility in certain conditions. Reduced visibility may increase the risk of a crash. Rivian is not aware of any crashes, injuries, or fatalities related to this condition.

Remedy: Pursuant to its recall determination, Rivian will replace the headlamp control modules on the affected vehicles free of charge.

Description: Rivian Automotive, LLC has decided that certain model year 2025 Rivian R1S and R1T vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) 108 and Technical Standards Document (TSD) 108 - Lamps, reflective devices, and assoc. equipment.

Diminished front turn signal lamp performance may cause reduced awareness of the vehicles intent to turn for road users in front of the vehicle. Reduced awareness of intent to turn may increase the risk of a crash. Rivian is not aware of any crashes, injuries, or fatalities related to this condition.

Remedy: Pursuant to its recall determination, Rivian will inspect and/or replace the front turn signal lamps on the potentially affected vehicles free of charge.

Glossary

First Owner

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

Manufacturer Recall

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico. Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota. Please consider this as you review a vehicle's estimated ownership history.

A state issues a title to provide a vehicle owner with proof of ownership. Each title has a unique number. Each title or registration record on a CARFAX report does not necessarily indicate a change in ownership. In Canada, a registration and bill of sale are used as proof of ownership.
